General Data Protection Notice for Event Participants

1 Who is responsible for data processing?

2 What is personal data?

'Personal data' means any information relating to an identified or identifiable natural person (e.g. name, address, e-mail address, photos and video recordings).

3 Processing of data due to participation in one of our events

3.1 Organisation and handling of the event

<u>Purpose</u>: We process your data transferred to us in order to ensure your participation in our event and to guarantee the smooth organisation and running of the event.

There is neither a legal nor a contractual obligation on your part to provide us with the data required to register for our event. However, if you do not provide the necessary data in the required scope, you may be refused to participate in the event.

<u>Data categories</u>: Basic data of the data subject (e.g. name, title, date of birth), contact data (e.g. address, email address, telephone number), health data (e.g. physical impairments, food allergies and intolerances), correspondence data (e.g. content of e-mails, registrations and cancellations)

Legal bases:

- » Art 6 (1) (f) GDPR Legitimate interests: Knowledge of the number of event participants and, if applicable, their special needs in order to be able to organise the event and make special arrangements in advance
- » Art 9 (2) (a) GDPR Explicit consent: If health data (e.g. food allergies, physical restrictions) are transferred

<u>Storage period</u>: We store your data until the purpose has been fulfilled. After fulfilment of the purpose, your data will only be stored if there is a legal obligation to retain it or another significant reason for further storage can be cited. This may be the case, for example, if we need your data to establish, exercise or defend against legal claims.

<u>Categories of recipients</u>: If necessary, your data will be transferred to other voestalpine Group companies (www.voestalpine.com/standorte) in compliance with data protection regulations. If your data is recorded and stored in IT systems or IT applications for the purpose of event participation, this data may also be transferred to processors (IT service providers).

3.2 Documentation and reporting

<u>Purpose</u>: Video and photo recordings are regularly made to document the event, which in turn can be published in reports about the event in newspapers, publications and on social media.

<u>Data categories</u>: Basic data of the data subject (e.g. name, title), company data (e.g. company name), video, photo and sound data (e.g. photos, video recordings, speech given), data that can be collected from publicly available sources (e.g. websites)

Legal bases:

- » Art 6 (1) (a) GDPR Consent
- » Art 6 (1) (f) GDPR Legitimate interests: Documentation of the event for internal company purposes (e.g. information for employees) and publication of event details to inform business partners and generate media coverage.

<u>Storage period</u>: We store your data until the purpose has been fulfilled. After fulfilment of the purpose, your data will only be stored if there is a legal obligation to retain it or another significant reason for further storage can be cited. This may be the case, for example, if we need your data to establish, exercise or defend against legal claims.

<u>Categories of recipients</u>: Professional photographers and filmmakers; if necessary, your data will be transferred to other voestalpine Group companies (www.voestalpine.com/standorte) in compliance with data protection regulations. If your data is recorded and stored in IT systems or IT applications for the purpose of event documentation, this data may also be transferred to processors (IT service providers).

4 Data transfer to third countries

Due to the complexity of today's data processing processes, we engage processors to process your data. As far as possible, we only use processors that are based within the European Union or the European Economic Area and are therefore subject to the GDPR.

In exceptional cases, however, we may transfer data to third countries (i.e. outside the European Union or the European Economic Area) and have it processed there. If we transfer data to third countries, the transfer takes place exclusively in compliance with the required conditions of admissibility (in particular the existence of an adequacy decision by the EU Commission, conclusion of standard data protection clauses including - if necessary - additional agreement of further technical and organisational as well as contractual measures). If your data is transferred to a third country, you can request a copy of the appropriate or suitable safeguards from our data protection organisation.

5 Rights of data subjects and the right to lodge a complaint

- » In accordance with Art 15 GDPR, you have the right to obtain confirmation from us as the controller as to whether or not personal data concerning you are being processed, and, where that is the case, you have the right of access to your personal data.
- » In accordance with Art 16 GDPR, you have the right to request the rectification of inaccurate data concerning you and/or the completion of incomplete personal data without undue delay.
- » In accordance with Art 17 GDPR, you have the right to obtain the erasure of your personal data.
- » In accordance with Art 18 GDPR, you have the right to obtain the restriction of processing of your personal data.
- » In accordance with Art 20 GDPR, you have a right to data portability.
- » In accordance with Art 21 GDPR, you have the right to object to the processing of your personal data.
- » If your data is processed on the basis of your consent, you have the right to withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.
- » Finally, you have the right to lodge a complaint with the supervisory authority responsible for you.
